



DEED OF RELEASE, ASSUMPTION OF RISK AND INDEMNITY

(FOR PARTICIPANTS **BELOW** 18 YEARS OLD)

(this "Deed")

In consideration of Singapore Turf Club ("**STC**") agreeing to allow the Participant (named below) to engage and participate in the equestrian riding lessons organised and conducted by Singapore Turf Club Riding Centre ("**STCRC**"), a riding centre managed by STC, or in any form of equestrian riding or in any activities on STC's premises (collectively, "**Programme**"),

We, Participant and the undersigned, on behalf of the Participant and for ourselves, our personal representatives, heirs, next of kin, spouses or assigns, do hereby:

- a. **CONSENT** to the Participant participating and engaging in the Programme under the terms and conditions of this Deed and agree that the Participant shall be subjected to the terms and conditions of this Deed and the attached Rules and Regulations that may be amended by STC from time to time. We warrant that the Participant accepts and will comply with and abide by fully the attached Rules and Regulations as may be amended by STC from time to time.
- b. **UNDERSTAND AND ACKNOWLEDGE** that the Programme is potentially dangerous and risky to and for the Participant and anyone attending the Programme and that the horses/ponies (whether owned by STC or not) may be dangerous and unpredictable, and in consenting to the Participant participating or engaging in the Programme, we acknowledge that we and the Participant accept and assume all danger and risk associated with and inherent in the Programme (including the possibility of an accident causing injury, death or property damage or loss) and that such acknowledgement is a condition precedent prior to the Participant participating or engaging in any capacity in the Programme.
- c. **RELEASE, DISCHARGE AND COVENANT NOT TO SUE** STC, its Committee, servants, agents, contractors and sponsors (collectively, "**Releasees**") from, and covenant not to sue the Releasees or any of them for, any and all claims, demands, actions, causes of actions, suits, controversies, obligations and liabilities of any kind and nature whatsoever relating to personal injury, death or property damage sustained directly or indirectly from the Programme, howsoever caused, regardless of the theory of liability (contract, tort or otherwise) and even if the Club has been advised of the possibility of such damages, and whether or not arising out of breach of contract, strict liability or negligence of Releasees or any other participant. We, jointly and severally, and in common, covenant to forever hold the Releasees harmless and to indemnify the Releasees from any claim, judgment, or expenses (including legal fees) that Releasees may incur arising out of any of the Participant's activities or the Participant's presence and/or behaviour on the premises of STC.
- d. **AGREE** to indemnify and will keep the Releasees indemnified against any claim, demand, writ, summons, suit, action, proceeding, judgment, order, decree, damages, costs, loss of expense of any nature (including legal fees) arising out of negligence, any breach of representation, warranty or undertaking herein contained or arising out of the Participant's participating or engaging in the Programme.



- e. **AGREE** that if any clause or sub-clause of this Deed is deemed invalid or unenforceable, then the remaining clauses and sub-clauses shall remain in full force and effect, and so far as possible, the said clauses or sub-clauses shall be deemed modified to the minimum degree possible so as to comply with applicable law and be valid and enforceable.

This Deed shall be governed by and construed in accordance with Singapore law.

WE HAVE READ THIS DEED. WE UNDERSTAND IT AS A RELEASE OF ALL CLAIMS. WE APPRECIATE AND ASSUME ALL DANGER AND RISK ASSOCIATED WITH AND INHERENT IN THE PROGRAMME. WE HEREBY CONFIRM THAT THE PARTICULARS DECLARED AND SUBMITTED IN THE RIDING APPLICATION FORM ARE ACCURATE AND COMPLETE.
